This license shall be an annual license, beginning June 1st and ending May 31st. Under said license, QRM grants the right to enter the Quail Ridge Ranch property for hunting, fishing, and other recreational purposes subject to the rules and regulations of QRM (see Addendum 1), which Licensee hereby acknowledges having received, read, understood and agrees to be bound by; and conditioned upon Licensee's execution of a Participant Release and Waiver of Liability, Assumption of Risk & Indemnity Agreement (See Addendium 2) and Agreement and Warning (see Addendium 3). This License is revocable with cause including, but not limited to, failure to pay the license fee, violations of the Rules and Regulations of QRM, consuming alcohol before or during a hunt or any other firearm activity, violation of game laws, property damage, disrespect for other hunters, spouses or guests, and any conduct unbecoming of a sportsman, as determined by QRM. This license excludes access or use of Quail Ridge Ranch property on Thanksgiving Day and Christmas Day. Guests are allowed as "Sub-licensees" at times as permitted in the Rules and Regulations and as approved by QRM and conditioned upon their execution of a Participant Release and Waiver of Liability, Assumption of Risk & Indemnity Agreement, as well as an Agreement and Warning. Licensee understands that QRM carries liability insurance solely for QRM's protection. It is the sole responsibility of licensee to carry individual insurance, which may or may not be included in their homeowner's policy. The license granted to the Licensee hereby includes a husband, wife, child under 18 years of age or younger living at home, and any child less than 22 years of age who is a full time student or a child up to the age of 26 who has paid a Junior Membership Fee. Licensees agree to abide by Rules and Regulations of QRM.
